## FUTURITY LATE NOMINATIONS

*Late nominations to the Futurity will be accepted after the January 15<sup>th</sup> deadline with a \$200 Late Nomination Fee. Any late payments MUST include a \$50 late fee per month missed. All fees must be paid by Sept 15, 2008.*

## FUTURITY ENTRY RULES

1. Futurity class is open to any horse which is a foal of 2005 or after. To enter in Futurity, horse must never have competed at any Barrel Race (including open shows, registered shows, rodeos, playdays, showdeos, futurities) prior to December 1, 2008 (Exception – Cannot have completed previously in this Futurity).
2. Owners may enter more than one horse. Owner does not have to ride. Rider may be male or female.
3. Horse papers must list the name of the current horse owner, transfers are not accepted. All prize money will be paid to the horse owner.
4. All barrel races will be held at the Jim Norick Coliseum of the Oklahoma State Fairgrounds in Oklahoma City, Oklahoma.
5. Open to all breeds of registered horses. Original papers must be presented at time of check-in.
6. Entries will be mouthed by a licensed horse veterinarian.
7. There will be 2 go-rounds, short-go and average in Futurity. Fastest times from the 2 go-rounds will go to the finals. Your slowest qualifying time will be dropped. Futurity Qualifying rounds will be paid in 2D format. Payoff will be progressive and will be 1 second split. The champions will be determined by your fastest go-round time combined with your Short Go time.
8. No refunds in any case. Payments must accompany nomination. Substitutions - \$150 by November 1. Must be same owner.
9. Office charge of 20% of total entry fees per horse for advertisement. 80% of entry fees and all added money will be distributed.
10. Owner and rider of each entry must be a 2009 member of BFA. Membership must accompany nomination.
11. Riders must qualify for Amateur status as per AQHA rules AND must provide copy of a current AQHA, APHA, or ApHA Amateur Card no later than November 1 to be eligible for BFA Amateur Incentive.
